



INVITATION TO BID FOR THE Construction of School Bldg. Day Care Center/Early Childhood Development Center

- 1. The City Government of Ilagan, through <u>LGSF-Support to Barangay Development Program of the National Task Force to End Local Communist Armed Conflict</u> FY 2022 intends to apply the sum of <u>TWO MILLION PESOS (P2,000,000.00)</u> being the Approved Budget for the Contract (ABC) to payments under the contract for the <u>Const. of School Bldg. Day Care Center/Early Childhood Development Center.</u> Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Ilagan now invites bids for the <u>Const. of School Bldg. Day Care Center/Early Childhood Development Center</u>, located at <u>Purok 3, Sindon Bayabo</u>, City of Ilagan, Isabela. Completion of the works is required for <u>one hundred twenty (120) calendar days</u>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules & Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Interested bidders may obtain further information from the City Gov't. Of Ilagan and inspect the bidding documents at the *BAC Secretariat Office* during Office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>Sept. 26-27, 2022</u> from the <u>BAC Secretariat Office</u> and website below and upon payment of a nonrefundable fee for the bidding documents in the amount of <u>FIVE THOUSAND PESOS (P5, 000, 00) only.</u>

It may also be downloaded free of charge from the website of the PhilGEPS & the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

- 6. The City Government of Ilagan will hold a Pre-Bid Conference on <u>Sept. 28, 2022 @ 2:00 pm at the Conference Room, City Hall</u> which shall be open to all prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before <u>2:00 pm, Oct. 10, 2022 at Conference</u> <u>Room, City Hall, City of Ilagan, Isabela</u>. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 16.
- 9. Bid opening shall be on <u>2:00 pm, Oct. 10, 2022 @ conference Room. City Hall</u>. Bids will be opened in the presence of the bidder's authorized representative who choose to attend the activity. Authorized representatives must bring letter of authorization from the board, owner or proprietor.
