



INVITATION TO BID FOR THE Improvement of Government Facilities • City Hall Bldg.(5M) • RHU | Bldg.(1.5M) • PNP Station (1.5M)

- 1. The City Government of Ilagan, through <u>20% Economic Development Fund (EDF)</u>, intends to apply the sum of <u>EIGHT MILLION PESOS (P8,000,000.00)</u> being the Approved Budget for the Contract (ABC) to payments under the contract for the <u>Improvement of Government Facilities City Hall Bldg.(5M) RHU I Bldg.(1.5M)</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Ilagan now invites bids for the <u>Improvement of Government Facilities City Hall Bidg.(5M) RHU I Bidg.(1.5M)</u>, PNP Station (1.5M) located at brgy. <u>San Vicente</u>, City of Ilagan, Isabela. Completion of the works is required for <u>one hundred eighty (180) calendar days</u>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules & Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Interested bidders may obtain further information from the City Gov't. of Ilagan and inspect the bidding documents at the <u>BAC Secretariat Office</u> during Office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>Sept. 19-20, 2022</u> from the <u>BAC Secretariat Office</u> and website below and upon payment of a nonrefundable fee for the bidding documents in the amount of <u>TEN THOUSAND PESOS (P10,000,00) Only.</u>

It may also be downloaded free of charge from the website of the PhilGEPS & the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

- 6. The City Government of Ilagan will hold a Pre-Bid Conference on <u>Sept. 21, 2022 @ 2:00 pm at the Conference Room, City Hall, City of Ilagan</u> which shall be open to all prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before <u>2:00 pm</u>, Oct. 04, 2022 at Conference Room, City Hall, City of llagan, Isabela. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 16.
- 9. Bid opening shall be on <u>2:00 pm , Oct. 04, 2022 @ conference Room. City Hall</u>. Bids will be opened in the presence of the bidder's authorized representative who choose to attend the activity. Authorized representative must bring letter of authorization from the board , owner or proprietor. 10.
