



**INVITATION TO BID FOR THE Reblocking of Roads •Marana 1st -Baculod (4M) •Sta. Barbara(2M) •Namnama(2M)**

1. The City Government of Ilagan, through 2021 Excise Tax intends to apply the sum of **EIGHT MILLION PESOS (P8,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Reblocking of Roads. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Ilagan now invites bids for the Reblocking of Roads •Marana 1st –Baculod (4M) •Sta. Barbara (2M) •Namnama (2M) located at brgys. Marana 1st, Baculod, Sta. Barbara & Namnama , City of Ilagan, Isabela. Completion of the works is required for ninety (90) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in section II Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules & Regulations (IRR) of RA 9184, otherwise known as the “Government Procurement Reform Act”.

4. Interested bidders may obtain further information from the City Gov’t. of Ilagan and inspect the bidding documents at the BAC Secretariat Office during Office hours.

5. A complete set of Bidding Documents may be acquired by interested Bidders on April 24-25, 2024 from the BAC Secretariat Office and website below and upon payment of a nonrefundable fee for the bidding documents in the amount of TEN THOUSAND PESOS (P10,000.00) Only.

It may also be downloaded free of charge from the website of the PhilGEPS & the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

6. The **City Government of Ilagan** will hold a Pre-Bid Conference on April 26, 2024 @ 2:00 pm at the Conference Room , City Hall, City of Ilagan which shall be open to all prospective bidders.

7. Bids must be duly received by the BAC Secretariat on or before 2:00 pm , May 08, 2024 at Conference Room, City Hall, City of Ilagan, Isabela. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 16.

9. Bid opening shall be on 2:00 May 08, 2024 @ conference Room, City Hall . Bids will be opened in the presence of the bidder’s authorized representative who choose to attend the activity. Authorized representative must bring letter of authorization from the board , owner or proprietor.
