



## INVITATION TO BID FOR THE Const. of Health Center @ San Isidro (1.5M) and Concreting of Flooring of Covered Court @ Tangcul-San Isidro E/S (1.5M)

- 1. The City Government of Ilagan, through <u>20% Development Fund</u> FY 2024 intends to apply the sum of <u>THREE MILLION PESOS (P3,000,000.00)</u> being the Approved Budget for the Contract (ABC) to payments under the contract for the <u>Const. of Health Center @ San Isidro (1.5M) and Concreting of Flooring of Covered Court @ Tangcul-San Isidro E/S (1.5M). Bids received in excess of the ABC shall be automatically rejected at bid opening.</u>
- 2. The City Government of Ilagan now invites bids for the <u>Const. of Health Center @ San Isidro(1.5M)</u> and <u>Concreting of Flooring of Covered Court @ Tangcul-San Isidro E/S (1.5M</u> located at brgy. <u>Tangcul & San Isidro</u>, City of Ilagan, Isabela. Completion of the works is required for <u>one hundred eighty(180)</u> <u>calendar days</u>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules & Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Interested bidders may obtain further information from the City Gov't. of Ilagan and inspect the bidding documents at the *BAC Secretariat Office* during Office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>March 06-07, 2024</u> from the <u>BAC Secretariat Office</u> and website below and upon payment of a nonrefundable fee for the bidding documents in the amount of <u>FIVE THOUSAND PESOS (P5,000.00) Only.</u>

It may also be downloaded free of charge from the website of the PhilGEPS & the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

- 6. The City Government of Ilagan will hold a Pre-Bid Conference on <u>March 08, 2024 @ 2:00 pm at the Conference Room, City Hall, City of Ilagan</u> which shall be open to all prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before <u>2:00 pm, March 20, 2024 at Conference Room, City Hall, City of Ilagan, Isabela</u>. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 16.
- 9. Bid opening shall be on <u>2:00pm March 20, 2024 @ conference Room, City Hall</u>. Bids will be opened in the presence of the bidder's authorized representative who choose to attend the activity. Authorized representative must bring letter of authorization from the board, owner or proprietor.
