





INVITATION TO BID FOR THE CONSTRUCTION OF COVERED COURT @ ALIBAGU ELEM. SCHOOL AND CONSTRUCTION OF COVERED COURT @ MINABANG ELEM. SCHOOL

- 1. The City Government of Ilagan, through <u>Special Education Fund</u> for the year 2025 intends to apply the sum of <u>FOUR MILLION SEVENHUNDRED SEVENTYFIVE THOUSAND PESOS ONLY(P4,775,000.00)</u> being the Approved Budget for the Contract (ABC) to payments under the contract for the <u>Construction of Covered Court @ Alibagu Elem. School and Construction of Covered Court @ Minabang Elem. School.</u> Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Ilagan now invites bids for the Construction of Covered Court @ Alibagu Elem. School and Construction of Covered Court @ Minabang Elem. School located at , Brgy. Alibagu and Minabang, City of Ilagan, Isabela. Completion of the works is required for One hundred eighty (180) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules & Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Interested bidders may obtain further information from the City Gov't. of Ilagan and inspect the bidding documents at the **BAC Secretariat Office** during office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>July 11- July 31, 2025</u> from the <u>BAC Secretariat Office</u> and website below upon payment of a nonrefundable fee for the bidding documents in the amount of <u>FIVE THOUSAND PESOS (P5, 000, 00) only</u>.

It may also be downloaded free of charge from the website of the PhilGEPS & the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

- 6. The City Government of Ilagan will hold a Pre-Bid Conference on <u>July 18, 2025 @ 2:00 pm at the Conference Room, City Hall</u> which shall be open to all prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before <u>2:00 pm, July 31, 2025 at Conference Room, City Hall, City of Ilagan, Isabela.</u> Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 16.
- 9. Bid opening shall be on <u>2:00 pm, July 31, 2025 @ Conference Room, City Hall</u>. Bids will be opened in the presence of the bidder's authorized representative who choose to attend the activity. Authorized representatives must bring letter of authorization from the board, owner or proprietor.
