



INVITATION TO BID FOR THE PROCUREMENT OF ANESTHESIA MACHINE WITH CARDIAC MONITOR WITH CAPNOGRAPH

- 1. The City Government of Ilagan, through <u>Capital Outlay of City of Ilagan Medical Center (CIMC)</u> intends to apply the sum of <u>FIVE MILLION EIGHTHUNDREDFIFTY THOUSAND PESOS ONLY (5,850,000.00)</u> being the Approved Budget for the Contract (ABC) to payments under the contract for the <u>Procurement of Anesthesia Machine with Cardiac Monitor with Capnograph</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Ilagan now invites bids for the <u>Procurement of Anesthesia Machine with Cardiac Monitor with Capnograph.</u> Delivery of the Goods is required <u>Fifteen(15) days</u> upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules & Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Interested bidders may obtain further information from the City Gov't. Of Ilagan and inspect the bidding documents at the *BAC Secretariat Office* during office hours.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>April 15, 2025 May 06, 2025</u> from the <u>BAC Secretariat Office</u> and website below upon payment of a nonrefundable fee for the bidding documents in the amount of <u>TEN THOUSAND PESOS (P10, 000, 00) only.</u>

It may also be downloaded free of charge from the website of the PhilGEPS & the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

- 6. The City Government of Ilagan will hold a Pre-Bid Conference on April 22, 2025 @ 2:00 pm at the Conference Room, City Hall which shall be open to all prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before <u>2:00 pm, May 06, 2025 at Conference Room, City Hall, City of Ilagan, Isabela</u>. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 16.
- 9. Bid opening shall be on <u>2:00 pm, May 06, 2025</u> @ conference Room. City Hall. Bids will be opened in the presence of the bidder's authorized representative who choose to attend the activity. Authorized representatives must bring letter of authorization from the board, owner or proprietor.
